



**LAUREL SPRINGS HOA
2017 POOL PARTY RULES**

1. A planned gathering of five (5) or more guests will be required to fill out a Pool Party Form.
2. Advanced booking must be made with the Property Manager, Krista Kugelman, at (770)889-7347 or manager@laurelspringshoa.com
3. There is a two (2) hour maximum for all parties.
4. One adult must be present for every THREE children under the age of 12.
5. Only two parties will be allowed on the same day.
6. The lifeguard on duty MUST sign off on this form below confirming that your area was properly cleaned up. Signed form must be returned to the Property Manager.
7. All Laurel Springs Pool Rules must be followed or you will be asked to leave the pool area.
8. Any damage to property, pool, restrooms, slide, etc will be paid for by the signed homeowner.
9. The Residents Club is not to be used except for proper use of the restrooms.
10. All clean-up will be responsibility of the signed homeowner.
11. Parties of 12 or more will be required to hire an additional lifeguard at the \$25 an hour.
12. The signed homeowner will be responsible for any outside party or unauthorized guests and will be subject to a fine of \$200. Their guests will be asked to leave the property immediately. Only owners in good standing with the HOA will be allowed to book parties. If there is an outstanding balance on your HOA account, you will not be allowed to host a party.
13. Fines will be applied to your HOA account should the rules not be followed or your area is not cleaned up.
14. **NO UNREGISTERED PARTIES WILL BE ALLOWED AND ANY OWNER CAUGHT HOSTING AN UNAUTHORIZED PARTY WILL BE SUBJECT TO A FINE AND/OR SUSPENSION FROM THE LAUREL SPRINGS AMENITY AREAS.**
